## 1.8 Definitions

<b>Site</b>	has the meaning given to it in clause 1.1;
<b>Terms</b>	means these terms and conditions of use as updated from time to time under clause 12;
<b>Unwanted Submission</b>	has the meaning given to it in clause 6.1;
<b>we</b>	means Fab Hunter Ltd, company registration number 12036194 , and the registered office

of which is at 2nd Floor College House, 17 King Edwards Road, Ruislip, London, United Kingdom, HA4 7AE and **us** or **our** shall have the same meaning); and

**you** means the person accessing or using the Site or its Content (and **your** shall have the same meaning).

## **2 Using the Site**

- 2.1 The Site is for your use only.
- 2.2 You agree that you are solely responsible for:

You agree not to adjust to try to circumvent or delete any notices contained on the Site (including any intellectual property notices) and in particular in any digital rights or other security technology embedded or contained within the Site.
- 4.3 Trade marks: Our website may include our trade marks and trade marks that belong to third parties. Other trade marks and trade names may also be used on the Site. The use of any trade marks on the Site is strictly prohibited unless you have our prior written permission.

## **5 Software**

- (a) were not foreseeable to you and us when these Terms were formed; or
  - (b) that were not caused by any breach on our part;
- 9.1.2 business losses; and
- 9.1.3 losses to non-consumers.

## **10 Events beyond our control**

We shall have no liability to you for any breach of these Terms caused by any event or circumstance beyond our reasonable control including, but not limited to, strikes,

lock-outs or other industrial disputes; breakdown of systems or network access; or flood, fire, explosion or accident.

## **11 Rights of third parties**

No one other than a party to these Terms has any right to enforce any of these Terms.

## **12 Variation**

These Terms are dated 26-05-2020. No changes to these Terms are valid or have any effect unless agreed by us in writing or made in accordance with this clause 12. We reserve the right to vary these Terms from time to time. Our updated Terms will be displayed on the Site and by continuing to use and access the Site following such changes, you agree to be bound by any variation made by us. It is your responsibility to check these Terms from time to time to verify such variations.

13.1 We will try to resolve any disputes with you quickly and efficiently.

13.3 If you and we cannot resolve a dispute using our complaint handling procedure, we will:

13.3.2 give you certain information required by law about our alternative dispute resolution provider.

13.4 If you want to take court proceedings, the relevant courts of the United Kingdom will have exclusive jurisdiction in relation to these Terms.

13.5 Relevant United Kingdom law will apply to these Terms.
